



## Consultation on a proposal to open a Cognition and Learning Unit at The Buckingham School

### **Proposal to open a Cognition and Learning Unit at The Buckingham School**

Buckinghamshire Council, with the support of the Governing Board of The Buckingham School, are seeking your views on our proposal to open a Cognition and Learning Unit at The Buckingham School from January 2027.

Over the last five years, the number of Special Educational Needs and Disabled (SEND) pupils with an Educational Health Care Plan (EHCP) has increased by 48% (1901 pupils). Current projections forecast a further 51% increase in the number of EHCP pupils over the next five years.

The number of secondary aged children with Cognition and Learning needs has risen by 30% over the last 5 years and we are expecting the numbers to increase further in the future.

As part of our SEND Education Sufficiency Strategy the Council sought expressions of interest from Schools interested in opening a secondary age inclusion unit. The Buckingham School submitted an expression of interest to open a Unit to meet the demand for places and we are therefore proposing to open a Cognition and Learning Unit. The proposal being progressed reflects the phased approach to the delivery of new SEND Units across the County which are prioritised by the profile of need by type and geography. The Council has no secondary ARP/Unit in the north of the county resulting in a significant gap in provision for C&L students. The provision of new SEND Units are a key element of the Service's Medium Term Financial Planning programme to ensure the council meets the increased demand for SEND places, with a particular focus on inclusion within Mainstream Schools.

The proposal at The Buckingham School would be an 8 place Unit for pupils with Cognition and Learning needs as detailed in their Educational Health Care Plan (EHCP). Only children whose EHCP states they need support from a unit would be admitted and admissions will be controlled by the SEND team; parents would not be able to apply directly to the school for a place in the unit. The 8 pupils would be in addition to the school's current Published Admission Number of 210.

### **What this proposal means for pupils and staff at the school**

A key aim of the unit is to enable pupils to access a mainstream curriculum, whilst accessing specific specialist support. Pupils attending the unit are likely to spend the majority of their time based within the new Unit. The new Unit will be self-contained with its own external

courtyard for external learning and recreation. Pupils in the Unit will be able to join in with parts of the school day, where appropriate.

Specialist teachers would be employed to manage the new Unit. All staff working in the Unit will have received specialist training on supporting children with Cognition and Learning needs. The Unit will be staffed with teachers and learning support assistants; additional professionals will support the children including a speech and language therapist and occupational therapist. Additional professionals will be employed depending on the needs of the children, such as a play therapist, an art therapist etc.

### **How the Unit would be funded**

The new Unit would be accommodated in an existing drama room which will be refurbished to provide a dedicated classroom, an intervention room and an office. In order to compensate for the loss of the existing drama room, the old lecture theatre will be refurbished to create a new multipurpose performance/drama space. The Unit will have its own outdoor courtyard which will be refurbished as part of the planned works.

The cost of the planned works would be funded using government funding that has been made available for providing new/expanding existing SEND provision across the county. Additional revenue funding would be provided to fund the Unit. It would therefore not have a detrimental impact on the school's existing revenue budget or impact on provision for pupils.

It is proposed that works would commence on the Unit during the summer 2026 and complete by the end of the year such that the new provision will open from January 2027.
