Overview

We want to hear your views on our proposal to vary and extend an existing Public Spaces Protection Order in High Wycombe Town Centre.

We have a key role to play in helping make local places safe to live, visit and work in. Tackling anti-social behaviour continues to be a high priority for us and our partners.

Public Spaces Protection Orders are aimed at ensuring public spaces can be enjoyed free from anti-social behaviour. They provide us with legal powers to deal with a particular nuisance or problem in a defined area.

It is key that we address and reduce these issues from occurring, by consulting with members of the public and other key stakeholders.

We want to hear from residents and organisations in High Wycombe Town Centre as well as those who visit the area.

What is a PSPO?

Public Spaces Protection Orders (PSPOs) are intended to deal with a particular nuisance or problem in a specific area that is detrimental to the local community's quality of life. This is achieved by imposing conditions on the use of that area, which apply to everyone.

Councils can use PSPOs to prohibit specified activities, and / or require certain things to be done by people engaged in particular activities, within a defined public area.

A single PSPO can be used to target a range of different anti-social behaviour issues. A PSPO can last for up to 3 years, after which it must be reviewed.

What can PSPOs be used for?

PSPOs can be used to restrict a broad range of activities.

Under section 59 of the Anti-Social Behaviour, Crime and Policing Act 2014, local authorities must be satisfied on reasonable grounds that the activity subject to an Order:

- has a detrimental effect on the quality of life of those in the locality (or it is likely that activities will take place and have such an effect)
- is (or is likely to be) persistent or continuing in nature
- is (or is likely to be) unreasonable
- justifies the restrictions being imposed.

How are PSPOs enforced?

Authorised officers from Buckinghamshire Council and the Police will be able to enforce the restrictions and requirements of a PSPO, which can include issuing Fixed Penalty Notices.

The Fixed Penalty Notice for a breach of a PSPO is £60 if paid within 10 days, and £100 if paid within 14 days.

High Wycombe Town Centre Public Spaces Protection Order (PSPO)

The High Wycombe Town Centre PSPO was introduced on 12 March 2020 to address anti-social behaviour in the public place.

The PSPO prohibits any person is from consuming alcohol or having an open container for alcohol in the restricted areas at all times. Anyone continuing to carry out these activities in the restricted areas is committing an offence.

There are exceptions to the restrictions. These are outlined in Schedule 2 of the PSPO document.

What we are proposing / consulting on

We are proposing to vary and extend the High Wycombe Town Centre Public Spaces Protection Order for a further 3 years. The variations are:

- An additional condition to enforce the PSPO:
 - “[where a constable or an authorised person reasonably believes that a person] has an open container of alcohol where to do so would be a breach of the prohibition”
- A change to the exceptions listed in Schedule 2 of the PSPO to state permission is granted by our Community Safety Team:
 - “a place where facilities or activities relating to the sale or consumption of alcohol are at the relevant time permitted by virtue of written permission granted by Buckinghamshire Councils’ Community Safety Team”

For full details and conditions of the Order, please see the varied High Wycombe Town Centre PSPO document.

A variation and extension are being proposed to prevent:

- Occurrence or re-occurrence of the activities identified in the Order, or
- An increase in the frequency or seriousness of the activities identified in the Order

If not varied and extended, the High Wycombe Town Centre PSPO will expire on 11 March 2023.
