#### Overview

Following recent boundary changes, there are a small number of proposed changes to polling districts and polling places in the county. Most polling places remain unchanged.

We welcome your view on these proposed changes.

Please note that the recent amendments to unitary ward and parliamentary constituency boundaries are no longer open to comment and are referenced on a listed mapping tool for your information only.

#### Polling districts, places and stations

Buckinghamshire is divided into polling districts. Each polling district has a polling place – in which are the polling stations where voting happens.

All voters are allocated to a polling district and a polling place.

There are currently 366 polling stations in Buckinghamshire.
