#### **Overview**

We want to hear your views on our draft Housing Strategy for Buckinghamshire.

We want everyone to have a suitable, secure and affordable place to live – our Housing Strategy shows what we will do to make this happen.

#### The strategy sets out:

- the housing challenges and opportunities in Buckinghamshire
- our approach to tackling housing needs
- how we will work together with all the partners involved in delivering housing in Buckinghamshire

Buckinghamshire Council is not itself a housing landlord – we do not let or manage any affordable housing. Instead, we play a role in enabling new affordable housing development and ensuring that Registered Providers and private landlords provide an affordable and well maintained housing stock.

This will be Buckinghamshire's first countywide Housing Strategy.

We want to hear your views on our draft priorities and actions.

#### **Priorities and actions**

To achieve the strategy, we have created 3 equally important draft priorities:

responding to the needs of our diverse population

- **better homes**: good quality, sustainable and matched to need
- **new homes**: affordable, accessible and appropriate

#### Each priority includes:

- what we will do to achieve it
- the challenges Buckinghamshire faces
- actions we are doing now
- proposed actions for up to 2029

### How the strategy has been developed

The strategy has been developed with a wide range of partners and we will continue working together to deliver it.

#### We have:

- built on the work of the Buckinghamshire Affordable Housing Statement adopted in May 2022.
- worked with housing and voluntary organisations to better understand key housing issues in Buckinghamshire
- reviewed population information and housing information to understand demand, conditions and affordability.

## Other strategies supporting housing in Buckinghamshire

The Housing Strategy is one of our plans to make sure everyone has a suitable, secure and affordable place to live.

Our other plans and policies include:

- Allocations Policy by which we let affordable housing in Buckinghamshire.
- Buckinghamshire Homelessness and Rough Sleeping Strategy 2022 to 2025 – which sets out priorities for both preventing and tackling homelessness.
- Buckinghamshire Tenancy Strategy which sets out what we expect from our registered housing providers for the tenancies and rent levels of affordable housing.

# What we are already doing to respond to the needs of our diverse population:

- managing the social housing allocations process through Bucks Home Choice
- providing a homelessness and housing advice service under Part VII of the Housing Act
- providing temporary accommodation to homeless households

- producing an updated Allocations Policy for Buckinghamshire this will ensure robust processes are in place for delivery of the Bucks Home Choice scheme and allocations process, including clear workflows and regular monitoring and cross checking of applications to ensure consistency of approach and fairness
- meeting with Registered Providers on a regular basis and as part of the Buckinghamshire Housing Management Forum
- working with registered partners and private developers to deliver suitable adapted/adaptable dwellings through planning obligations and other opportunities

### Other actions we will take to respond to the needs of our diverse population:

- produce a new Tenancy Strategy including guidelines for Registered Providers on Affordable Rent levels
- develop a Supported Housing Strategy which will include prospective housing delivery for older persons, persons with physical disabilities, and other types of supported housing
- achieve the targets for developing affordable housing options as set out in the Buckinghamshire Adult Social Care Accommodation Market Analysis November 2022
- work with Registered Providers and other housing developers to understand role played by sheltered housing and other accommodation for older people in the area and whether some housing schemes should be remodelled to better meet current needs
  - Consider innovative new options for specialist housing (for example: extra-care villages with a dementia inclusive design)
- with our partners, produce a housing options guide for younger people with Special Educational Needs and Disabilities (SEND); ensure appropriate advice and signposting is available to make good choices
- explore ways of increasing the number of one bed properties available in the private and social rented sectors which would be suitable for young people, including care leavers under the agreed Pathways Protocol

# What we are already doing to achieve better homes:

- supporting the Buckinghamshire Council Energy Doctor scheme (funded by the Shared Prosperity Fund)
- supporting sustainable warmth upgrade grant programmes, such as Home Upgrade Grant (HUG2), Solar Together, which are being carried out by Buckinghamshire Council

- through our work with houses in multiple occupation (HMOs), we are delivering increased levels of safe and secure accommodation for single people
- the Buckinghamshire Disabilities Facilities Grants and Housing Improvement and Adaptations Policy is being updated to ensure that it continues to achieve the following:
  - o improve and promote the physical and mental health of residents
  - o prevent accidents
  - o enable residents to live safely at home, as independently as possible, for longer
  - reduce hospital admissions and enable speedy discharge from hospital
  - o make best use of adapted and adaptable accommodation

#### Other actions we will take to achieve better homes:

 work with Registered Providers and other care/support agencies to agree best ways to tackle under-occupation, including incentives where appropriate in order to generate more turnover in family-sized accommodation

### What we are already doing to achieve new homes:

- working with Registered Providers to facilitate delivery of new schemes, helping to identify sites and secure funding as appropriate
- supporting Registered Providers with funding for garage-site developments
- ensuring that housing (including affordable housing) is included in regeneration plans by the Council and partners

#### Other actions we will take to achieve new homes:

- work proactively to ensure that the planning process accelerates delivery of affordable housing applications in acceptable locations
- explore opportunities for 'build to rent' schemes, including the use of institutional investment.
- explore opportunities for the Council to deliver more housing utilising its land, property and financial assets, including any potential role for Consilio, the council's property company

- Consilio was set up by South Bucks Council in 2017 as a wholly owned local authority trading company to allow the council to facilitate income generation
- o it has now transferred to Buckinghamshire Council
- o it owns a limited number of property assets
- identify three council-owned sites to bring forward for new development and complete these developments by 2027 – three new developments completed and let by December 2027
- agree priorities for capital funding (including commuted sums) and implement a list of priorities for section 106 monies to be developed

# How we developed the draft Buckinghamshire Housing Strategy 2024 to 2029

In May 2022, we adopted an affordable housing position statement. This set out our approach to support and increase the delivery of affordable housing. We have built on the work of the affordable housing statement in our draft Housing Strategy.

We have worked with housing and voluntary organisations to better understand key housing issues in Buckinghamshire.

We have also reviewed key housing data, including:

- an overview of Buckinghamshire, including the results of the Census
   2021 and the indices of multiple deprivation 2019
- housing demand, including homeless statistics, housing register and allocations data, research into housing needs among special needs groups in Buckinghamshire
- housing conditions, including information from registered providers on stock condition and government data on Energy Performance Certificates and fuel poverty
- housing affordability, including earnings data and house price/rental data

More information on how we have developed the draft Buckinghamshire Housing Strategy 2024 to 2029 is included in the full draft Strategy.
