Overview

We want to hear your views on our draft strategy to better support autistic people.

Around 1.1% of people in the UK aged 5 years and over is autistic. In Buckinghamshire this is about 5,400 children, young people and adults.

Autistic people in Buckinghamshire have told us that they want to:

- live as independently as possible
- have the same opportunities and experiences as everyone else
- use the services they need when they need them
- work with us to change our policies, approach and services

This is our vision too.

Draft Buckinghamshire Autism Strategy 2023 to 2027

Our autism strategy sets out what we need to do to make this vision happen. It includes 5 equally important priorities:

- improving awareness and understanding of autism
- tackling health and care inequalities
- developing a needs-based approach so that autistic children and young people get the best start in life

- developing better support for employment and meaningful activities
- ensuring more autistic adults maintain their independence

These priorities come from what autistic people have told us. They also cover national and local strategies.

Each priority has some areas of focus. These are what we need to do to make the priority, and the strategy vision, happen.

What autism is

Being autistic does not mean you have an illness or disease. It means your brain works in a different way from other people.

Autism affects each person in different ways. It affects how you:

- process information, perceive the world around you and make sense of your place in it
- communicate, relate to and interact with others

If you're autistic, you're autistic your whole life.

We have developed this strategy with autistic people, their families and support networks:

stakeholder scoping meetings

 we worked with partner organisations and autistic people to help develop priorities

Talkback engagement project

 we asked Talkback UK to run surveys and workshops to find out what professionals, autistic people and their families thought of current services

youth engagement

o we ran surveys to hear from autistic children and young people

Improving awareness and understanding of autism

Our ambition

This priority is about making sure:

- autistic people feel more welcome, listened to and understood by our staff and across Buckinghamshire
- the understanding and acceptance of autism are improved
- our staff understand how autism can affect people differently, including the difference in how autistic women and girls present, and to help change people's behaviour towards autistic people and their families
- autistic people can access our spaces and services, just like everyone else

Areas of focus

What we need to do to improve awareness and understanding of autism:

- improve our own awareness and understanding we will focus on this first
- autistic people training all frontline police officers and staff in autism awareness
- Youth Offending Service offer 1:1 support to autistic people, or people suspected of being autistic, on probation and post-release
- autism awareness training for parents of teenagers as well as younger children
- review the special educational needs and disabilities (SEND) local offer website and other online directories to be more accessible for autistic people and their families and support network

Tackling health and care inequalities

Autistic people have told us that they don't always get the same health and care support as people who are not autistic.

Tackling health and care inequalities is about making sure everyone has the same access to health and care services when they need them.

Our ambition

This priority is about making sure:

- we reduce the health and care inequalities autistic people face and show that autistic people are living healthier lives
- we reduce waiting times for high quality autism assessments, improve our diagnostic pathways and the support that autistic people need
- physical and emotional wellbeing is promoted through prevention and community services – reducing reliance on health services
- we review current and future housing needs to ensure Buckinghamshire has more housing and housing related support
- getting a diagnosis will better link with our education offer, support services and health offer

accessing services and support is not always dependent on receiving a diagnosis

Areas of focus

What we need to do to tackle health and care inequalities:

- invest in our assessment and diagnostic services
- hospitals collect information to better deliver services
- health organisations working together across Berkshire West,
 Oxfordshire, and Buckinghamshire to develop different approaches to diagnosis
- education takes a needs-led approach, moving away from the assessment model – this will mean it is less critical to receive a diagnosis to get support
- working with health organisations to fund services with a best practice, needs led and earliest intervention approach

Developing a needs-based approach – so that autistic children and young people get the best start in life

Not all autistic people want or have a formal diagnosis – but may still need support.

A needs-based approach means that education, social care, and health services are for anyone who needs them – whether they have diagnosis or not.

Some services in Buckinghamshire will still need a diagnosis (diagnosis led) as their support is linked to national guidance rather than local guidance.

Our ambition

This priority is about making sure:

- autistic people can get education support with or without a diagnosis
- education and school staff are trained to understand autism and how to better support needs (including differences in behaviour and environmental need)
- fewer autistic people experience emotionally based school avoidance (EBSA) – difficulty attending school due to emotional reasons
- autistic people and their families feel prepared for adulthood whether they get a job, go into further education, or look for other opportunities

Areas of focus

What we need to do to develop a needs-based approach:

 change how autistic children access education support (needs rather than diagnosis led)

- start Autism Standards Training for all schools across Buckinghamshire –
 outlining best practice support for autistic young people
- publish a new Therapies Strategy to meet the needs of children and young people who need speech and language, communication and occupational therapy
- making changes to physical environments to meet the needs of autistic people
- create a new, accessible Preparation for Adulthood Toolkit to support families and professionals as autistic children and young people become adults

Developing better support for employment and meaningful activities

Our ambition

This priority is about making sure:

- autistic people have more opportunities to work in areas where their skills are a 'good fit'
- autistic people understand work, training, and volunteering opportunities – so they can make decisions about their future
- people offering advice and support have more awareness and understanding of reasonable adjustments and employer responsibilities
- more employers understand what autistic people can do and provide work or volunteering opportunities

Areas of focus

What we need to do to develop better support for employment and meaningful activities:

- we will work with employment and training support to improve the quality and amount of support offered by:
 - o improving our Preparing for Adulthood offer
 - launching the Reasonable Adjustments Toolkit for our staff and health colleagues – which promotes and sets good practice
- work with the local job centres to share opportunities and have more Disability Confident employers
- encourage local businesses to attend autism related events and training to enhance their skills

Ensuring more autistic adults maintain their independence

Our ambition

This priority is about making sure:

 we work with autistic people and stakeholders to address gaps in our current support

Areas of focus

What we need to do to ensure more autistic adults maintain their independence:

- address the social support gap for autistic adults autistic adults who do not have associated care needs have told us about difficulties accessing social support services
- evaluate support for autistic people with and without social care support
 including online and / or in-person 'drop ins'
- work with health partners to deliver reasonable adjustments across services and settings
- look at how to improve specialist housing
