### **What is the purpose of this consultation?**

Quinton Parish Council were one of the earliest parish councils within Buckinghamshire to begin the process of creating a Neighbourhood Development Plan (also known as a Neighbourhood Plan).

In September 2012, the former Aylesbury Vale District Council (AVDC) approved the Neighbourhood area. The area covers the whole of Quinton Parish Council area.

The Parish Council then commenced work on a Neighbourhood plan. Their plan was submitted for examination and the plan was allowed to proceed to a referendum where it was supported. As a result, the plan was Made (Adopted) by the former Aylesbury Vale District Council in October 2016.

However, with the existing Neighbourhood plan being over 5 years old and the significant changes being brought to the village by new housing development, the parish decided it was necessary to refresh the Neighbourhood Plan and commenced work on a modification to the existing plan.

Quinton Parish Council have now completed their local community engagement on the proposed modifications to their Plan and have submitted the final version to us. The next stage of the process is for us, as the local authority, to carry out a public consultation on the submitted modifications to the Plan.

This is an opportunity for local people to comment on it before it goes to independent examination.

The Quinton Neighbourhood Plan modifications include:

- An amendment to the Settlement Boundary to include land allocated or planned for development, and new commitments which have planning consent.

- An alteration to the Settlement Boundary to further safeguard a heritage asset: The Quainton Windmill.
- A replacement of most of the other Neighbourhood plan policies with updated wording so they may continue to be in general conformity with the Vale of Aylesbury Local Plan (VALP).
- The inclusion of a Policies Map to provide a visual representation of the key Modified Plan policies.

## What happens next

Following consultation, we will collate the responses and submit them to an independent examiner. The examiner will consider public comments and ensure the Plan meets conditions laid out in the Localism Act and other relevant regulations.

The examiner will decide if the modifications are so significant that they would change the nature of the plan as existing and so need to be agreed via a referendum. Or, if the changes wouldn't alter the nature of the plan and so it can be made (adopted) without the need for a referendum.

1. If the Plan passes independent examination and no referendum is required, Buckinghamshire Council will adopt it as part of local planning policy to assess planning applications in the Neighbourhood Area.
2. If it is decided the Plan needs to go to a referendum, the council will organise one. If the Plan gets 50% or more 'Yes' votes in the referendum, Buckinghamshire Council will make the Plan and adopt it as part of local planning policy to assess planning applications in the Neighbourhood Area.
