We are creating two long-term plans for the future:

- The Local Plan for Buckinghamshire to shape and manage future development across Buckinghamshire
- Local Transport Plan 5 (LTP 5) to set out the priorities for all types of transport across Buckinghamshire

Planning and transport are closely linked. When new homes, shops and places to work are built, they need to be accessible and connected to the road and public transport network. They also need to be easy to walk and cycle to and around.

We want to make sure new transport schemes are planned well from the start of any development.

We have drafted a vision and objectives for each plan. They set out what we think Buckinghamshire should be like in 2040 and how this can be achieved.

The draft vision and objectives have been developed from what you have already told us. From November 2021 to February 2022, we asked for views on what is important to your area and what future priorities should be.

The Local Transport Plan 5 vision and objectives also consider our role as the local highway authority and maintaining safe and usable roads. We have a duty to manage our road network so that traffic moves efficiently.

We now want to hear your views on the draft visions and objectives. Tell us what you think of them and if there's anything else that should be included.

We want the plans to reflect the needs and ambitions of our communities.

The Local Plan for Buckinghamshire

Our new local plan will show where development can happen and protect places where it needs to be carefully controlled.

It will set out what new development must do, such as:

- building the right number and size of homes
- allocating land for new jobs
- creating good places to live including shops and public open spaces
- contributing to the infrastructure people need such as roads, schools and health facilities
- protecting the environment by supporting wildlife, beautiful landscapes, historic places and managing flood risk

Why we need a local plan

A local plan is a major factor when deciding if a planning application is granted or refused.

It sets out how we plan to manage future growth across Buckinghamshire.

A local plan brings benefits for people who live, work, or visit the area, through:

- making sure there are enough of the right homes and workplaces
- getting the infrastructure in the right place at the right time such as new parks and schools
- helping to address climate change, protecting and preserving our most valued landscapes and habitats

Local plan draft vision and objectives

Our draft vision shows what we want the local plan to achieve by 2040.

It covers climate change, the natural environment, housing, infrastructure, jobs and how Buckinghamshire connects to other places.

To achieve the vision, we have created 8 draft objectives:

- natural and built environment
- mitigating / adapting to climate change
- provision of homes
- quality of place
- community health and wellbeing
- infrastructure
- economy and jobs
- transport, physical and digital connectivity

The objectives are equally important and cover all major aspects of the local plan. Each objective has an aim and a set of actions.

Local Transport Plan 5 (LTP 5)

Local transport plans are a requirement of the Transport Act (2000). They set out a local authority's ambitions, policies and plans for future investment in local transport.

This will be the fifth local transport plan for Buckinghamshire. The current plan (LTP4) was published in 2016 by the former Buckinghamshire County Council.

LTP5 will set out the long-term priorities for all types of transport in Buckinghamshire up to 2040.

Why we need a local transport plan

Local Transport Plan 5 will set out how we will meet our commitments to tackle transport related carbon emissions as part of our Climate Change and Air Quality Strategy.

For people living and working in Buckinghamshire it means:

- ensuring new homes are built in well-connected locations and can be accessed by sustainable travel options – such as public transport
- supporting people to make the switch towards using electric vehicles
- offering attractive sustainable options for travel such as safe cycling routes and a reliable bus system
- taking action to reduce delays to journeys and addressing the impacts of traffic congestion where people live and work

Local Transport Plan 5 draft vision and objectives

Our draft vision shows what we want the Local Transport Plan to achieve by 2040.

It covers net zero progress, sustainable and active travel, minimising the impacts of car travel, and connections within and outside Buckinghamshire.

To achieve the vision for 2040, we have created 3 draft objectives:

- connecting our economy
- decarbonising our transport system
- building places for people

The objectives are equally important and cover all types of transport in Buckinghamshire. Each objective has a suggested set of actions.

The Local Plan for Buckinghamshire vision

Our draft vision shows what we want the local plan to achieve by 2040.

Draft local plan vision for 2040:

In 2040, we have sustained the essential rural character of Buckinghamshire, with its network of small towns and villages.

In particular, we have maintained the area covered by Green Belt, have protected the Chilterns Area of Outstanding Natural Beauty (AONB) and other valued local landscapes from harmful development, and enlarged both the AONB and the Green Belt where justified.

Buckinghamshire is mitigating and adapting to climate change through the enhancement of valued local landscapes, supporting local nature recovery, significant new tree planting and natural habitat creation.

Initiatives to reduce the need to travel, the provision of active and sustainable travel choices, and the delivery of new renewable energy schemes have reduced harmful emissions.

We have created sustainable new communities through the delivery of well-designed housing for all types of need, including key worker housing, together with the social, digital and physical infrastructure needed to support them.

Our new employment sites provide the right spaces for our businesses to grow and generate investment.

Together, these have been built to high environmental standards in carefully chosen locations best able to accommodate growth.

Buckinghamshire has cemented its reputation as a leader in creative industries, digital technologies, innovation and engineering, well connected to a network of businesses in the Midlands, London and the South East.

It is seen as a vibrant place to grow local skills and businesses.

High-quality mixed-use developments have revitalised our town centres e.g. those of Aylesbury, High Wycombe, Chesham, Buckingham and Princes Risborough, delivering public realm and local transport improvements.

To achieve the vision, we have created 8 draft objectives.

These are equally important and cover all major aspects of the local plan. Each objective has an aim and a set of actions.

Objective 1: Natural and built environment

Aim: To conserve and enhance Buckinghamshire's valued natural, historic, and built environments, to ensure they are protected from inappropriate development.

To achieve this objective, the local plan will:

- a. sustain the predominantly rural character of Buckinghamshire
- b. protect valued landscapes including the Chilterns Area of Outstanding Natural Beauty (AONB) and the Green Belt from inappropriate development
- c. conserve and enhance special places for nature and create a connected county-wide network of green and blue infrastructure which maximises opportunities for biodiversity net gain with the creation of new priority habitats and green infrastructure
 - green infrastructure includes open spaces, parks, woods, footpaths and cycleways
 - blue infrastructure includes ponds, rivers, lakes and floodplains
- d. improve water quality in our rivers and watercourses, prioritising our chalk streams

Objective 7: Economy and jobs

Aim: To diversify and expand the economy by delivering the right employment opportunities in the right places, supporting economic recovery, regenerating town centres and enabling delivery of education, training and skills to enhance the employability of Buckinghamshire residents.

To achieve this objective, the local plan will:

- a. enhance our economic assets by supporting Enterprise Zones, strategic and locally important employment areas

Objective 8: Transport, physical and digital connectivity

Aim: To improve connectivity across and between Buckinghamshire towns and villages with regional and national centres beyond by securing new sustainable transport infrastructure, upgrading existing infrastructure and improving digital connectivity.

To achieve this objective, the local plan will:

- a. maximise the connectivity opportunities presented by large-scale strategic transport schemes such as East West Rail to focus the location of growth and encourage inward investment in Buckinghamshire
- b. create safe and attractive walking and cycling routes as the first choice for shorter journeys for those who are able
- c. diversify, extend and enhance public transport provision including planning for low-carbon innovations, facilitating changes of mode to complete car-free journeys
- d. facilitate effective transport solutions for those with mobility challenges
- e. direct road freight to the most appropriate routes and plan for facilities that support sustainable freight activity (e.g. consolidation centres and community delivery hubs) and first mile / last mile solutions
- f. support the provision of digital infrastructure to the most remote parts of Buckinghamshire

Local Transport Plan 5 (LTP5) vision

Our draft vision shows what we want the Local Transport Plan to achieve by 2040.

The LTP5 vision will be used to help make decisions on what transport schemes we prioritise and how we deliver infrastructure to connect people and places.

It has been designed to closely align with the local plan vision to achieve supporting outcomes.

Draft local transport plan vision for 2040:

In 2040 Buckinghamshire will have substantially tackled its transport related carbon emissions and be on target to net zero by 2050.

We will have done this by prioritising sustainable growth locations as well as increasing alternative fuel opportunities; offering viable, inclusive and

attractive public transport; encouraging healthy and active travel for shorter local trips; and greening our highway network.

We will have delivered high quality, future proofed and sustainable transport links to our local economic centres and housing sites as well as ensuring our economy is supported by faster connections to the Midlands, London and the South-East.

We recognise the continuing importance of the car in supporting individuals' freedom and independence in our rural setting and we will have focused on minimising the impacts of car travel on communities.

We will have done this by focusing investment on congestion hotspots and key corridors, ensuring through-traffic is routed away from residential areas, and delivering people-focused public realm schemes in town and village community centres.

Objective 1: Connecting our economy

This objective focuses on maximising investment into transport for the benefit of residents and local businesses.

Suggested actions to achieve this objective, include:

- a. manage our highway assets, with focus given to schemes that reduce time lost to congestion
- b. focus investment on our key road corridors to improve productivity
- c. deliver faster, easier transport connections to London, the Midlands and the South-East
- d. facilitate sustainable travel options for all users to our town centres and high streets, visitor attractions and leisure facilities, Enterprise Zones and key employment centres
- e. ensure developers forward fund and deliver transport infrastructure ahead of occupancy
- f. prepare and provide for increasing freight vehicle movements
- g. continue to be a living lab for transport innovation

Objective 2: Decarbonising our transport system

Decarbonisation means reducing carbon emissions. 26% of carbon emissions in Buckinghamshire come from transport (not including motorways). 65% of these emissions are from cars.

The <u>Department for Transport's Decarbonisation Plan</u> sets out the role of local transport plans in achieving a reduction in emissions.

Our transport plan will need to show that our policies and schemes will reduce carbon emissions from transport in Buckinghamshire.

Suggested actions to achieve this objective, include:

- a. support location and design of new housing and employment sites to minimise the need for travel by car, for example using elements of 20-minute walkable neighbourhoods where appropriate
- b. utilise the transport network to improve digital connections which will reduce the need for travel

- c. improve alternative options to encourage 'mode shift' and reduce car dependency
- d. make it realistic and safe for more people to walk, wheel, and scoot for shorter local journeys
- e. increase opportunities to use and normalise alternative fuels
- f. prepare our highway network for climate change impacts
- g. utilise the highway network to support biodiversity and reduce carbon, such as increasing wildflowers on roadside verges

Objective 3: Building places for people

This objective focuses on aligning our transport ambitions with other aspects of council services, such as town planning and regeneration, public health, and environmental health.

Suggested actions to achieve this objective, include:

- a. direct non-essential motorised journeys away from residential areas and community centres / high streets
- b. optimise traffic signals along corridors to 'smooth' traffic flow through residential areas improving overall journey times for drivers, and reducing air quality and noise impacts for local residents
- c. encourage transition away from combustion engine
- d. design walking and cycling-friendly neighbourhoods, for people and goods deliveries
- e. deliver high quality public realm improvements which meet the needs of all users of the street space
- f. where appropriate, utilise the transport interventions made because of HS2 and East West Rail projects
- g. improve road safety for pedestrians, cyclists, equestrians and motorcycles, our most vulnerable road users
- h. improve our Rights of Way network to support the needs of all users, including mobility and visually impaired users
