**Recommendations:** Our recommendation is for the Amersham Parking Review to proceed to Statutory Consultation.

**Reason for decision:** All decisions are a result of two informal consultations where residents, schools, businesses, and commuters were contacted to seek their opinion on the proposals.

## Executive summary

- The Amersham Parking Review 2020 is a town wide parking review which has had two informal consultations to gain views on the most appropriate parking controls and restrictions for each road in question. We would like permission to take these proposals to a statutory consultation.

## Legal and financial implications

- The budget has already been secured by Local Area Forum monies.
- We are following The Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996.

## Corporate implications

- This project is in compliance with the Parking Delivery Plan (PDP) which is an update to the Parking Implementation Plan (produced in 2017) which is designed to help shape, manage and deliver Buckinghamshire Council's Vision for Parking. The Amersham Parking Review 2020 is also in accordance with the new Local Transport Plan LYP4 covering March 2016-2036.
- An Equality Impact Assessment will be carried out after the Statutory Consultation has finished, and before the final decision has been made on how to proceed with the Amersham Parking Review 2020.

## Consultation and communication

- All decisions are a result of two informal consultations where residents, schools, businesses, and commuters were contacted to seek their opinion on the proposals.
- All councillors under the new unitary authority have been contacted and are supportive that the Amersham Parking Review 2020 continues.

## Next steps and review

- Statutory Consultation is due to start on the 19<sup>th</sup> June and end on 17<sup>th</sup> July. Once it is complete, the feedback will be collated, analysed and reviewed by the parking team, parking engineers and all of the councillors involved. A key decision report (KRD) will then be produced and the final decision to proceed is planned to be in late September.
