STATEMENT OF REASONS

THE BUCKINGHAMSHIRE COUNCIL (PROHIBITION OF WAITING, LOADING AND STOPPING) AND (ON-STREET PARKING PLACES) ORDER 2021 (AMENDMENT 00*) ORDER 202* & THE BUCKINGHAMSHIRE COUNCIL (TRAFFIC MOVEMENT) ORDER 2021 (AMENDMENT 00*) ORDER 202*

It is proposed to introduce restrictions on those lengths of road below, some of which have been in place since the central government's initiative during COVID-19 to encourage people back into the town centre using Temporary Traffic Regulation Orders (TTRO). Separate further TTRO's were later introduced under the initiative to encourage walking and more sustainable forms of travel. Replacing those TTRO's with permanent TRO's aligns with the latest Aylesbury Public Realm regeneration initiative.

The table below identifies the proposed changes to restrictions for the streets named and the reasons for proposing the restriction.
