Consultation

Dear Resident,

Statutory Consultation for the improvements to the Buckingham Railway Walk – Signal Controlled Toucan Crossings & Shared Use Path Improvements – 15 August to 12 September 2025.

Buckinghamshire Highways are proposing to improve the Buckingham Railway Walk between Tingewick Road and the A421 Ring Road, Buckingham. The proposals are listed in the table below:

Location (and Extents)	Proposal
A421 Ring Road (east of junction with Great Slade Industrial Park)	Introduce new signal controlled toucan crossings
Tingewick Road (approximately 171 metres east of the junction with Dunstan Street)	
Buckingham Railway Walk (from Tingewick Road in a south-easterly direction to Station Terrace and the land owned by the University of Buckingham)	Surfacing improvements between 2.5 and 3.5 metre wide where possible along the railway walk and conversion of the existing permissive path into shared use pedestrian and cycle path. Proposal includes improved wayfinding, solar studs and seating along the route.
Buckingham Railway Walk (from the A421 Ring Road in a north-westerly direction to the land owned by the University of Buckingham)

We will develop the proposals based on what local residents and key stakeholders tell us. If the feedback shows people support the proposals, we will begin the process of implementing the two signal controlled toucan crossings and the new shared use pedestrian and cycle path, and we will update you again to confirm the proposals.
