BUCKINGHAM RAILWAY WALK – SIGNAL CONTROLLED TOUCAN CROSSINGS & SHARED USE PATH IMPROVEMENTS & CYCLE TRACKS ORDER 202X

NOTICE IS HEREBY GIVEN that Buckinghamshire Council as the local highway authority under the Road Traffic Regulation Act 1984 and all other enabling powers, proposes to introduce two new signal controlled toucan crossings and to designate sections of the existing Buckingham Railway Walk to **shared use cycle track** (under Section 3 (1) of the Cycle Tracks Act 1984 having undertaken the consultations required by Regulation 3 of the Cycle Tracks Regulations 1984).

SCHEDULE

- **A421 Ring Road (east of junction with Great Slade Industrial Park) & Tingewick Road (approximately 171 metres east of the junction with Dunstan Street)** – introduce two new signal controlled toucan crossings
- **Buckingham Railway Walk (from Tingewick Road in a south-easterly direction to Station Terrace and the land owned by the University of Buckingham)** – Surfacing improvements between 2.5 and 3.5 metre wide where possible along the Railway Walk and conversion of the existing permissive path into shared use pedestrian and cycle path. Proposal includes improved wayfinding, solar studs and seating along the route.
- **Buckingham Railway Walk (from the A421 Ring Road in a north-westerly direction to the land owned by the University of Buckingham)** – Surfacing improvements between 2.5 and 3.5 metre wide where possible along the Railway Walk and conversion of the existing permissive path into shared use pedestrian and cycle path. Proposal includes improved wayfinding, solar studs and seating along the route.

The consultation opens on **Friday 15 August 2025** and closes at **11:59pm on Friday 12 September 2025**.
