### **Statutory Consultation for the implementation of Traffic Calming Features in the Castlefield Area of High Wycombe**

Buckinghamshire Highways are proposing to introduce traffic calming measures in the Castlefield Area in High Wycombe. These measures are designed to limit and deter anti-social driving from occurring in the area and to improve safety amenities for road users and pedestrians. Such proposed measures include speed humps, raised tables, modifying junctions, and chicanes.
