 7. EXISTING TREE CANOPY TO BE TRIMMED UP TO 5.5m HEIGHT OVER CARRIAGEWAY & 2.5m HEIGHT OVER FOOTWAY AND VERGE PRIOR TO WORK WITH APPROVAL VIA THE OVERSEEING ORGANISATION.
 8. EXISTING YELLOW ZIG-ZAGS TO BE REMOVED, NEW REPLACEMENT YELLOW ZIG-ZAGS TO BE ADDED, NORTH SIDE. ONE NEW ASSOCIATED "NO WAITING" ROAD SIGN TO BE INSTALLED.
 9. EXISTING DOUBLE YELLOW LINES TO BE EXTENDED SOUTH SIDE AND PROPOSED DOUBLE YELLOW MARKING ON NORTH SIDE, AS SHOWN.
