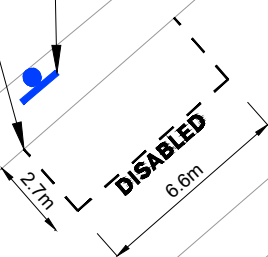
It is proposed to introduce Disabled Bays at various locations mentioned in the below table and the reasons for proposing the Disabled Bays.

Crossfield Road (Outside No. 46)	Introduce Disabled Badge Holders Only Bays	By authorising the advertisement of the proposal, Buckinghamshire Council (while having regard to the matters specified in Section 122 Subsection (2) of the Road Traffic Regulation Act) has given consideration to its duty under Section 122(1) of that Act as to: <i>“secure the expeditious, convenient and safe movement of vehicular and other traffic (including pedestrians) and the provision of suitable and adequate parking facilities on and off the highway [...]”</i>

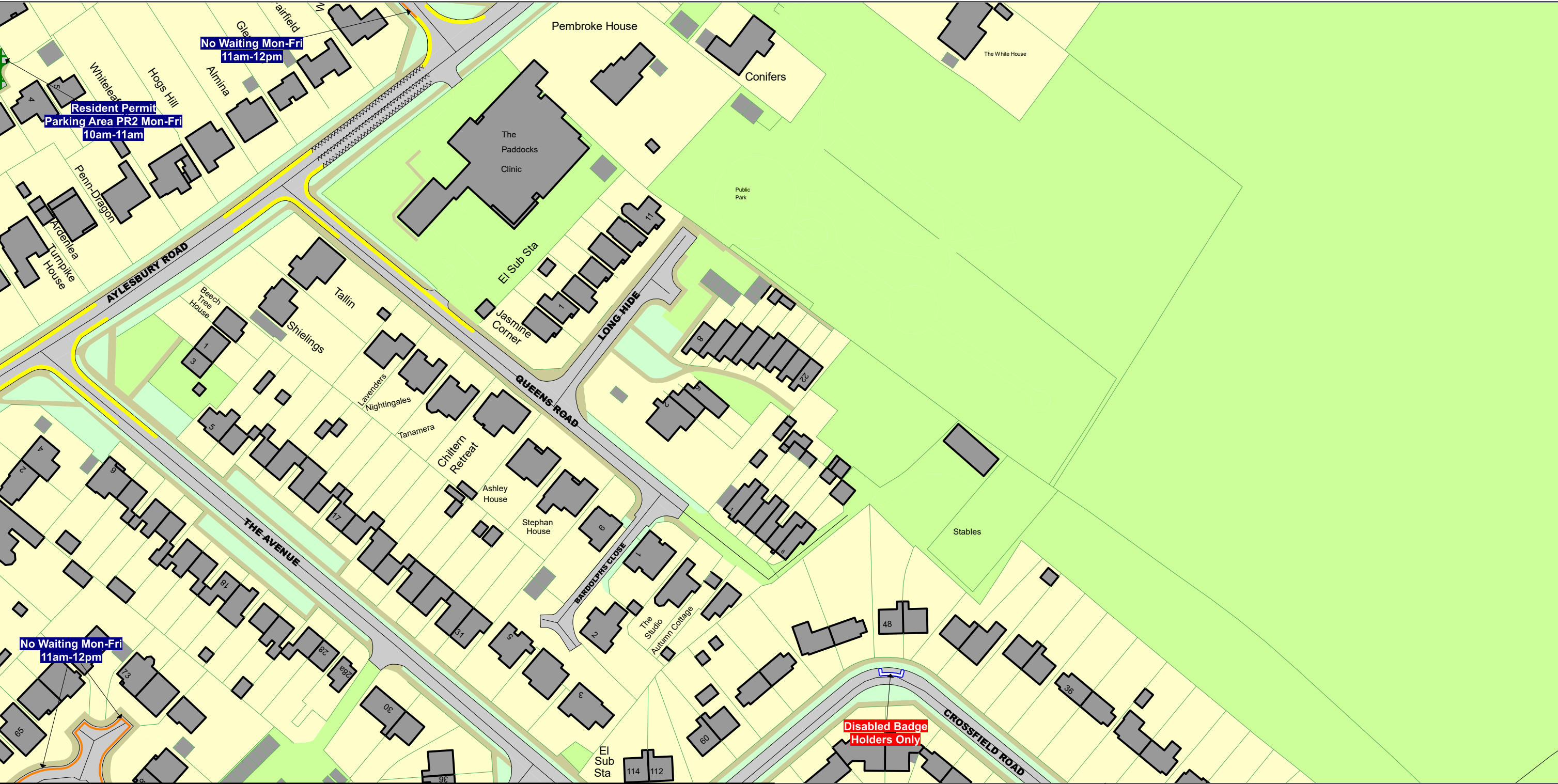

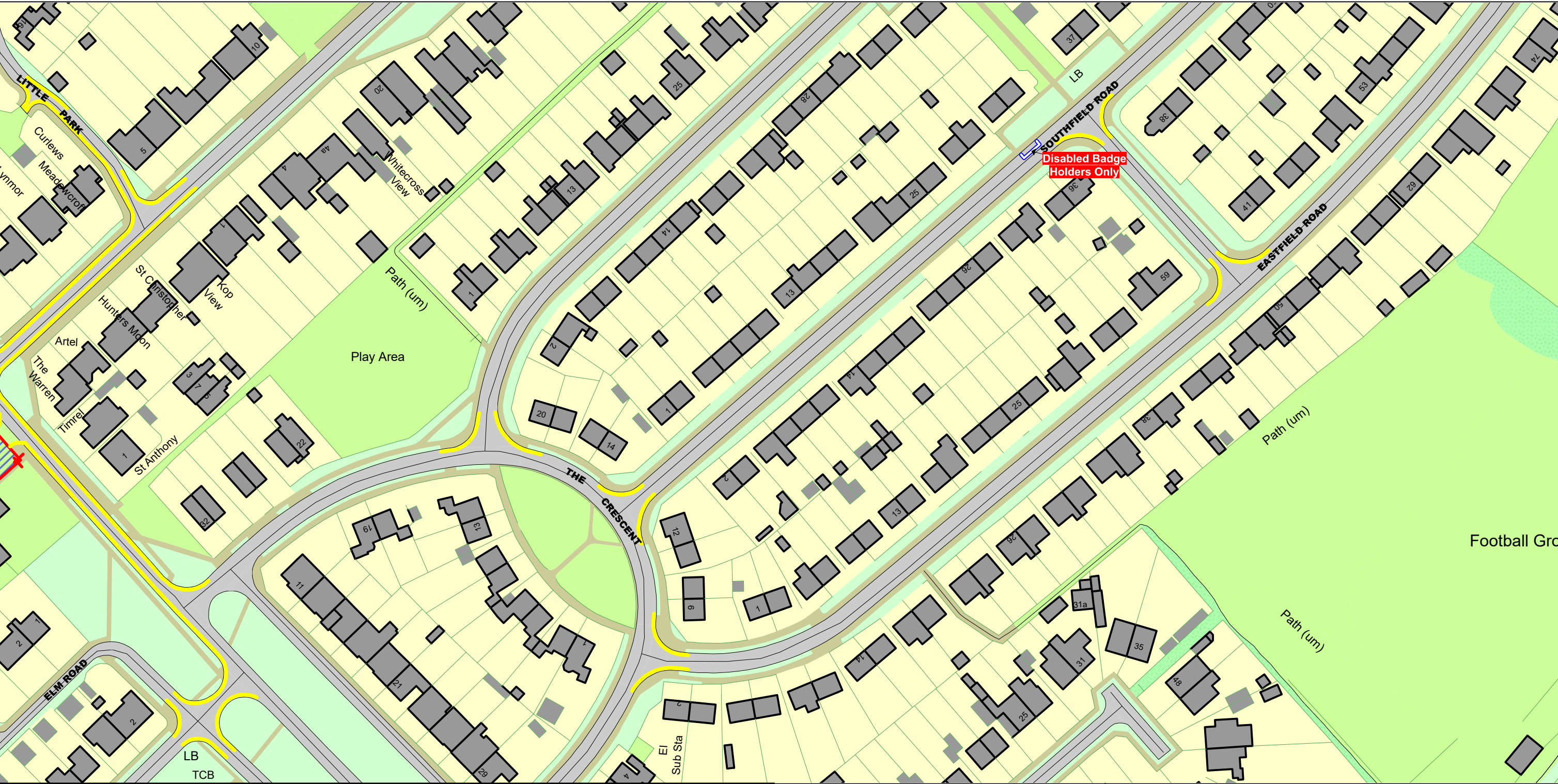
