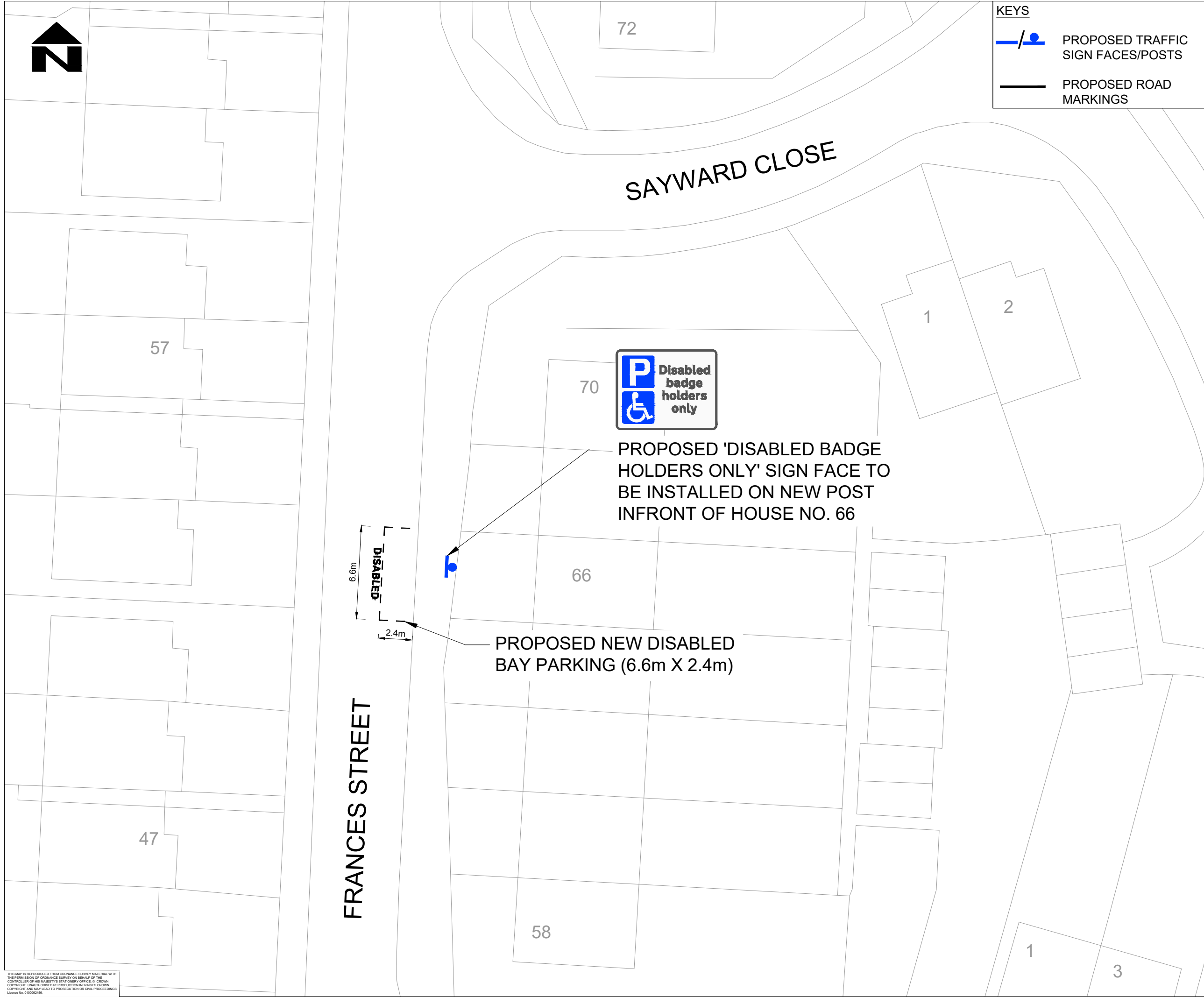


STATEMENT OF REASONS


