## NOTICE OF INTENT HICKS FARM RISE, HIGH WYCOMBE

Notice is hereby given that Buckinghamshire Council in exercise of its powers under sections 90A - 90I of The Highways Act 1980, in accordance with the Highways (Road Humps) Regulations 1999 and relevant sections of the Road Traffic Regulation Act 1984 intends to introduce a series of traffic calming features.

The general effect of the notice will be to construct vertical physical measures on Hicks Farm Rise and their locations are as follows –

- (a) A pair of flat-topped road cushions, centre line will be situated at a distance approximately 51m south of the junction with Baring Road;
- (b) A pair of flat-topped road cushions, centre line will be situated at a distance approximately 156 metres south of the junction with Baring Road;
- (b) A pair of flat-topped road cushions, centre line will be situated at a distance approximately 126 metres north of the junction with St Hughes Avenue;
- (d) A pair of flat-topped road cushions, centre line will be situated at a distance approximately 35m north of the junction with Gayhurst Road.

The speed cushions will be constructed of pre-fabricated rubber – road hump measurements will be 1.7m wide, 3.0m long and not exceeding 75mm in height [subject to permitted tolerances]. The proposed measures will assist in reducing traffic speeds on Hicks Farm Rise, thereby creating a safer environment for pedestrians and other road users.
