The Buckinghamshire Council (Static) Order 2021 (Amendment No 000*) Order 202*

The Buckinghamshire Council (hereinafter referred to as "the Council") in exercise of its powers under sections 82, 83 and 84 and part IV of schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.
