The Buckinghamshire Council (Speed Limit) Order 2021 (Amendment No *) Order 202*

The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No *) Order 202*

NOTICE IS HEREBY GIVEN that Buckinghamshire Council proposes to introduce a number of Traffic Regulation Orders under Sections 84(1), (2) and (3), Section 122 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 in the areas of Calvert, Steeple Claydon, Quainton, Stoke Mandeville, Twyford and Wendover, as part of the High Speed Rail 2 works:

- **Addison Road, Steeple Claydon** (From a point approximately 17 metres north of the southern end of Addison Road at its junction with Calvert Road to a point 24 metres south of its junction with Redland Close) – Introducing a 50mph speed limit Order.
- **Perry Hill, Steeple Claydon** (From a point approximately 215 metres north of the junction with School Hill to a point approximately 30 metres north of its junction with West Street) – Extend the 50mph speed limit currently present.
- **West Street, Twyford** (From a point approximately 60 metres north of its junction with Portway Road to its junction with Perry Hill Road) – Introduce a 40mph speed limit Order.
- **West Street, Twyford** (Original Route) – Revoke existing 'Weak Bridge No Vehicles Over 18 Tonne mgw' restriction.
- **Fidlers Field Road, Quainton** (From a point approximately 300 metres southeast of its junction with Harpers House Farm Access to a point approximately 79 metres north of the junction) – Introducing a 30mph speed limit Order.
- **Station Road, Quainton** (From a point approximately 430 metres south of its junction with Quainton Road to Waddesdon to No. 125 Station Road, approximately 309 metres northeast of the existing *Leafwood* access) - Introducing a 30mph speed limit Order.
- **A413 Small Dean, Wendover** (From the existing 40mph just south of the entrance to the HS2 Rocky Lane Depot in a northerly direction for a length of approximately 550m) – Extending the existing 40mph speed limit Order.
- **School Hill, Calvert** (From the 30mph / National Speed Limit terminal signs east of the railway bridge in a westerly direction towards the junction with Brackley Lane) - Introducing a 30mph speed limit Order.
- **A4010 (Stoke Mandeville Relief Road – Whole Length)** – Introducing a 50mph speed limit Order and shared use pathways.
