Statutory Consultation for the introduction of a raised table and Double Yellow Line extension on Warren Wood Drive, High Wycombe.

Buckinghamshire Highways are proposing to introduce a raised table and extend a section of Double Yellow Lines on Warren Wood Drive, High Wycombe. These works are part of Buckinghamshire Council's Keep Hill Woods Project, with the aim of improving the connection between the new developments and The Rye and is also part of the High Wycombe Local Cycling & Walking Infrastructure Plan.
