Dear Resident / Business Owner,

Statutory Consultation for the introduction of a 30mph speed limit Traffic Regulation Order (TRO) along Poplar Way and Willow Lane, Ickford.

Buckinghamshire Highways are proposing to introduce a 30mph speed limit Traffic Regulation Order (TRO) along Poplar Way and Willow Lane, Ickford. A proposal to introduce this TRO has been made as the development does not have adequate streetlighting facilities to automatically restrict the roads to 30mph under the Road Traffic Regulation Act (RTRA) 1984.

Under Section 81 of the RTRA, a restricted road has a speed limit of 30mph. Section 82 then goes on to define what a restricted road is, which is where:

“[There] is provided on it a system of street lighting furnished by means of lamps placed not more than 200 yards apart”

If a road is not classified as *restricted*, the speed limit defaults to the national speed limit. As Poplar Way and Willow Lane are single carriageways, the speed limit is defaulted to 60mph.

We will develop the proposals based on what residents and key stakeholders within the area tell us. If the feedback provided shows people support the proposal, we will begin the process of implementing this speed limit, and we will update you again to confirm the proposal.
