Path at Ellen Road, Aylesbury

Dear Residents,

Consultation for the proposal of introducing Signalised Toucan crossing and upgrading existing footway to shared use at Ellen Road j/w Churchill Ave, Aylesbury

Buckinghamshire Highways is proposing to introduce a Signalised Toucan Crossing outside Mandeville school and upgrade the footways to shared-use paths. This includes the southeast footway of Ellen Road, from Orwell Close to the Churchill Avenue roundabout (on the school side), and the northeast footway of Ellen Road, from the pedestrian refuge to the Churchill Road roundabout. These changes aim to provide a safer off-carriageway route for cyclists and pupils, reducing collision risks caused by insufficient footway width or lack of official designation as a shared use path.
