Statutory Consultation for Introduction of Parking Restrictions

We are proposing to introduce a restricted parking zone from A41 / Putlowes Road junction to the adjoining Waddesdon Greenway accesses and along Putlowes Drive. The works consist of a series of yellow repeaters signs at approximate 30m intervals to ensure appropriate enforcement of the no waiting restrictions.

The restrictions are being introduced to create a safer environment for residents and road users as well as encourage compliance with the Highway Code Rule 242 to not leave vehicle or trailer in a dangerous position or where it causes any unnecessary obstruction of the road; and 243 which prohibits parking anywhere you would prevent access for Emergency Services; and in front of an entrance to a property.
