Dear Resident / Business Owner,

Statutory Consultation for the introduction of a Traffic Regulation Order for a 30mph Speed Limit Order within the Rose Farm development, Longwick.

Buckinghamshire Highways is proposing to introduce a 30mph Speed Limit Traffic Regulation Order on the following roads within the Rose Farm development, located off Thame Road, Longwick.

The Traffic Regulation Order is required because the roads are not subject to a system of street lighting and therefore do not automatically become restricted roads with a 30mph speed limit. The proposed Order would establish a 30mph speed limit on the roads listed below.
