**Notice is hereby given** that Buckinghamshire Council proposes to make the above-named Orders under the Road Traffic Regulation Act 1984.

The effect of the Orders is to introduce or amend various restrictions on roads across High Wycombe (Table 1) and Gerrards Cross (Table 2) as listed below:
