The Buckinghamshire Council (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) Order 2021 (Amendment No *) Order 202* The Buckinghamshire Council (Traffic Movement) Order 2021 (Amendment No *) Order 202*

Notice is hereby given that Buckinghamshire Council proposes to make the above-named Orders under the Road Traffic Regulation Act 1984.

The effect of the Orders is to introduce or amend various restrictions on roads across High Wycombe (Table 1) and Gerrards Cross (Table 2) as listed below:

Bull Lane, Church Square, Corn Market, Church Street, Crown Lane, High Street, Paul's Row, Queens Square, White Hart Street	Revocation of existing "Pedestrian Zone No waiting at any time, No Loading at any time and No vehicles except for permit holders" (<i>where applicable</i>)
	Introduce "Pedestrian Zone No Waiting at Any Time and No Loading 6:00am-10:30am & 3:30pm-6:00pm" AND "Pedestrian Zone No Vehicles except Permit Holders 6:00am-10:30am & 3:30pm-6:00pm"
Castle Street (between <i>Priory Road and Church Street</i>)	Revocation of existing "Pedestrian Zone No waiting at any time, No Loading at any time and No vehicles except permit holders" AND AMEND TO "No waiting at any time, No Loading at any time"
Church Street	Revocation of "Goods Vehicles Loading only Mon-Sat 6am-6pm" parking bays
Church Street (between <i>Castle Street / Priory Road and Oxford Street</i>)	Revocation of existing "Pedestrian Zone" AND AMEND TO "No waiting at any time and No Loading at any time"
High Street (between <i>Corporation Street and Cornmarket / Church Square</i>)	Revoke "Goods Vehicles Loading only Mon-Sat 6am-6pm" AND "Goods Vehicles Loading only 6am-6pm/No Stopping 6pm-6am except taxis"
Paul's Row	Revocation of existing "Restricted Parking Zone No waiting at any time" AND "Motorcycle Parking Place"

Road Name (And Extents)	Proposal
South Park Drive (between <i>No.10 & No.18</i>)	No Waiting at any time (Double Yellow Lines)
