Dear Resident / Business Owner,

Statutory Consultation for the introduction and amendment of parking restrictions at various locations near Taplow Railway Station

Buckinghamshire Highways is proposing to introduce a number of parking restrictions (including pay-by-phone) on a number of roads near the railway station. These proposals are aimed to resolve the issues that have been caused by obstructive parking, following the start of the Elizabeth Line services in May 2022.

Taplow Parish Council has funded and implemented a Temporary Traffic Regulation Order (TTRO) to minimise the obstruction whilst a permanent solution is found. The Parish Council has also conducted two informal consultations with residents, with many supporting the proposed pay-by-phone scheme.

You are invited to review the proposals and share any thoughts on the proposals. Please read below to find out how to respond to this consultation.
