Decision:	Approval to proceed with the Statutory Consultation for the implementation of a Traffic Regulation Order (TRO) for the introduction of various parking restrictions across multiple roads in Taplow.

#### 1. Background

Reason for decision:

1.1 Elizabeth Line services began at Taplow Railway Station in May 2022, increasing station usage. This led to widespread obstructive parking on nearby roads, affecting residents and station users.

1.2 Taplow Parish Council conducted two informal consultations with residents, gaining strong support for a pay-by-phone parking scheme. The scheme aims to introduce on-street paid parking bays and implement parking restrictions to reduce congestion.

- 1.3 Taplow Parish Council has funded and implemented a Temporary Traffic Regulation Order (TTRO). Emergency yellow lines were installed on Approach Road to ensure the road remains unobstructed during the implementation of the project.
- 1.4 Buckinghamshire Council has identified several locations within Taplow where restrictions need to be implemented or modified to resolve the issues caused by obstructive parking as mentioned in Section 1.1 of this report.
- 1.5 The proposed locations, extents, and restrictions are detailed in the following tables, as well as shown in Appendix A:

#### 6. Financial & Legal Implications

- 6.1 Buckinghamshire Council will be fully funding the statutory consultation using 'invest to save funding'.
- 6.2 Traffic Regulation Orders are made under the provisions of Sections 1, 2 and 4 for the Road Traffic Regulation Act (RTRA) 1984.
- 6.3 Section 122 of the RTRA 1984 places a duty on Buckinghamshire Council to secure the expeditious, convenient, and safe movement of vehicular and other traffic (including pedestrians), on its highway.
- 6.4 Regulation 14 of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulation 1996 states that an order making authority may modify an order, whether in receipt of any objections or otherwise, before it is then made.
- 6.5 When the decision is taken and recommendations agreed, a Traffic Regulation Order (TRO) will be made. Correspondents to the consultation and those who will likely be affected will be informed of the decision taken.
- 6.6 If approved, this key decision will be the authority for Buckinghamshire Council to 'make' as well as publicise the TRO and advertise a Notice of Making in the local press in accordance with the

Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1996.
