Dear Resident/ Business Owner,

Statutory Consultation for the proposed implementation of a Raised Table with zebra and parallel cycle crossing, convert sections of existing footway into shared use pedestrian and cycle facility and the amendment of a permanent Traffic Regulation Order (TRO) for parking restriction amendments on Thame Road, Haddenham.

Buckinghamshire Highways is proposing to introduce a raised carriageway table with a zebra and parallel cycle crossing, convert the existing footway into a shared-use pedestrian and cycle facility, widen the footway to improve access to a bus stop, increase the width of the existing shared-use pedestrian and cycle facility to 3 metres, relocate two existing bus stops and amendment of parking restrictions to accommodate the proposed crossing as part of crossing improvements on Thame Road.
