The Buckinghamshire Council (Speed Limit) Order 2021 (Amendment No 001) Order 2022

The Buckinghamshire Council (hereinafter referred to as “the Council”) in exercise of its powers under sections 82, 83 and 84 and part IV of schedule 9 to the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, and after consultation with the Chief Officer of the Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order.

1. This Order may be cited as The Buckinghamshire Council (Speed Limit) Order 2021 (Amendment No 001) Order 2022 and shall come into operation on the 9th day of March 2022.
2. As from the date upon which this Order comes into operation, the provisions of The Buckinghamshire Council (Speed Limit) Order 2021 (shall be varied as follows:

(a) To update schedule.
