

Proposed changes to home to school transport from September 2023 consultation

Overview

We want your views on proposed changes to council-run school bus charges (Spare Seats scheme), our Home to School Transport Policy (0 to 25 year olds) and our Post-16 Transport Policy Statement for 2023 to 2024 to make them easier to understand.

We have reviewed how we charge for spare seats on school buses, our Home to School Transport Policy and our Post-16 Transport Policy Statement.

This consultation is your opportunity to tell us your views on proposals for:

- Spare Seats Scheme charging options
- Updates to our home to school transport policies

Any changes will apply for the 2023 to 2024 academic year onwards and will apply to both new and existing customers.

Spare Seats Scheme charging options

We run school buses for children who are eligible for free school transport.

After we have allocated seats to all young people who are eligible for free school transport, the Spare Seats Scheme offers paid-for seats on timetabled Council-run school buses.

In 2021 to 2022, Buckinghamshire Council spent approximately £4 million on school buses. At the same time, income from spare seat ticket sales was £0.5 million - contributing towards the overall costs of running school buses.

The current Spare Seats Scheme charge depends on age, distance and whether boarding within or outside of Buckinghamshire. Customers have told us that this structure is complex and difficult to understand.

We are proposing to simplify school bus ticket charges for the Spare Seats Scheme. The proposed changes will even out the cost of travel over a child's whole school career by:

- reducing the cost of post-16 travel for some Spare Seats passengers
- making it easier for parents and carers to know upfront how much they will have to pay before applying for a seat

We want to know your preference between three proposed Spare Seat scheme charging options:

- **Option 1: Distance banding** (small difference between distance bands)
- **Option 2: Distance banding** (medium difference between distance bands)
- **Option 3: Flat fee** (regardless of distance)

Under all proposed options:

- We are removing the price increase that may apply when Spare Seat customers reach sixth form age (post-16)
 - No post-16 young person will see an age-related increase in the cost of their spare seat while they continue to travel on the same bus to the same school
 - The parent / carer of an 11 year old child will be able to plan ahead. They will know they won't be subject to an age-related price increase once their child is post-16 - if they continue to travel on the same bus to the same school
- Our Spare Seats scheme charges aim to be easier to understand
- Non-Buckinghamshire Council residents will pay a higher fee to customers who live within Buckinghamshire

There are no other changes proposed to the Spare Seat Scheme offer, application process or prioritisation policy. Only the Spare Seat charges will change from the 2023 to 2024 academic year.

Proposed changes to school transport policy

The Home to School Transport Policy sets out our approach to providing transport to schools / educational settings for students up to 19 years old (up to 25 years for students with special educational needs and disabilities).

The Post-16 Transport Policy Statement sets out transport arrangements for students aged 16 and over. It specifies the transport arrangements we consider necessary for sixth form students to attend education or training.

We are proposing some minor changes to our school transport policies to make them clearer and easier to understand. These updates are highlighted in yellow in the draft policy documents below. We want to hear your views on whether these updates have made our policies easier to understand.

We are also proposing a 3% increase to the charge for Post-16 students with SEND using Buckinghamshire Council arranged transport. This is below the rate of inflation (9.9% as of September 2022) and despite rising transport costs.

We are not proposing any further substantial changes to the Home to School Transport Policy or the Post-16 Transport Policy Statement 2023 to 2024.

What happens next

We will consider all the feedback we receive before deciding on the new Spare Seat Scheme charging approach and the proposed changes to Home to School Transport Policy and Post-16 Transport Policy Statement. The decision will be made by the Leader of Buckinghamshire Council in April 2023.

Once the decision has been made, we will revise the spare seat charges for September 2023 and publish the new Home to School Transport Policy and Post-16 Transport Policy Statement.

They will apply to school transport from September 2023. We will update this page with the outcome of the consultation.

Spare Seats Scheme charging proposals for 2023 to 2024

We want to know your preference between three charging options for the Spare Seat Scheme for 2023 to 2024:

Option 1: Distance banding (small difference between distance bands)

- For Buckinghamshire Council residents, the charge will depend on the distance travelled between our Council-run school bus bus-stop and school.
- There is a flat charge for non-residents.
- This proposal reduces the existing distance bands from 5 to 3. There is a £22 and £21 increase respectively between distance bands 2 and 3.
- The maximum increase that a Buckinghamshire resident customer will pay is capped at 9.9% (an extra £80 per year or £6.67 per month).
- There is a maximum reduction in price for Buckinghamshire students of sixth form age of £464 per year (34.4%).

The proposed option 1 distance bandings related charges for 2023 to 2024 are:

Option 2: Distance banding (medium difference between distance bands)

- For Buckinghamshire Council residents, the charge will depend on the distance travelled between our Council-run school bus bus-stop and school.
- There is a flat charge for non-residents.
- This proposal reduces the existing distance bands from 5 to 3. There is a £53 increase between each band.
- The charge for distance band 1 (0 to 3.99 miles) is lower than in Option 1.
- The maximum increase that a Buckinghamshire resident customer will pay is capped at 13.2% (an extra £106 per year or £8.83 per month).
- There is a maximum reduction in price for Buckinghamshire students of sixth form age of £438 per year (32.4%).

The proposed option 2 distance bandings and charges for 2023 to 2024 are:

Option 3: Flat rate proposal

- The charge is set regardless of distance travelled, based on whether you are Buckinghamshire Council resident or not.
- There is a maximum reduction in price for Buckinghamshire students of sixth form age of £482 p.a. (35.7%).

The proposed flat rate charges for 2023 to 2024 are:

Customer	Proposed charge for 2023 to 2024
Buckinghamshire Council resident	£868
Non-Buckinghamshire Council resident	£1,200

All proposed charging proposals:

- Remove the price increase that may apply for Post-16 Spare Seats customers, making it easier to plan ahead
- Aim to make our Spare Seats scheme charges easier to understand

- Charge non-residents a higher fee than customers who live within Buckinghamshire
- Have been modelled to:
 - Make no additional income for the Council
 - Achieve zero percentage increase on average across all Buckinghamshire school bus ticket (Spare Seats Scheme) customers. We based our calculations on 2022 to 2023 Spare Seats prices and 2022 to 2023 Spare Seat passenger profile
 - Show comparison of all options following a 3% uplift to 2022 to 2023 Spare Seat fees

As with current charges, payments can be made termly or yearly online, or by monthly Direct Debit over 8 months.

What would these options mean for Spare Seats customers?

Example 1: Theo, age 12 and travels 3 miles

Theo is 12 years old, lives in Lacey Green and travels 3 miles to school. Under the current Spare Seat fee structure his parents will be paying £806 for his seat in 2023 to 2024.

Under the Council's proposed changes his parents would see the following change for the 2023 to 2024 academic year:

- **Option 1 Distance banding** (small difference between distance bands). The new fee would be £843. This is £37 or 4.6% (£3.08 per month) more than they would have paid under the current charging structure
- **Option 2 Distance banding** (medium difference between distance bands). The new fee would be £806, which is the same as they would have paid under the current charging structure
- **Option 3 Flat rate**. The new fee would be £868. This is £62 or 7.7% (£5.17 per month) more than they would have paid under the current charging structure

Example 2: Imogen, age 14, and travels 4.5 miles

Imogen is 14 years old, lives in Aston Clinton and travels 4.5 miles to school. Under the current Spare Seat fee structure her parents will be paying £806 for her seat in 2023 to 2024 (current pre-16 price is regardless of distance). Under the Council's proposed changes her parents would see the following change for the 2023 to 2024 academic year:

- **Option 1 Distance banding** (small difference between distance bands). The new fee would be £865. This is £59 or 7.3% (£4.92 per month) more than they would have paid under the current charging structure
- **Option 2 Distance banding** (medium difference between distance bands). The new fee would be £859. This is £53 or 6.6% (£4.42 per month) more than they would have paid under the current charging structure
- **Option 3 Flat rate**. The new fee would be £868. This is £62 or 7.7% (£5.17 per month) more than they would have paid under the current charging structure

Example 3: Tariq, age 17 and travels 10 miles

Tariq is 17 years old, lives in Twyford and travels 10 miles to school. Under the current Spare Seat fee structure his parents will be paying £1,350 for his seat in 2023 to 2024 (current post-16 price is distance-banded).

Under the Council's proposed changes his parents would see the following change for the 2023 to 2024 academic year:

- **Option 1 Distance banding** (small difference between distance bands). The new fee would be £886. This is £464 or 34.4% (£38.67 per month) less than they would have paid under the current charging structure
- **Option 2 Distance banding** (medium difference between distance bands). The new fee would be £912. This is £438 or 32.4% (£36.50 per month) less than they would have paid under the current charging structure
- **Option 3 Flat rate**. The new fee would be £868. This is £482 or 35.7% (£40.17 per month) less than they would have paid under the current charging structure

Other options considered

We considered other options that were not taken forward:

- Continue with the current scheme
 - Parent / carer feedback has been that the current pay rates are very difficult to understand because different rates apply. Charges

depend on age, distance and whether boarding within or outside of Buckinghamshire.

- Current scheme has 13 different price points and it is not possible to know upfront what families will have to pay before applying.
- Current scheme has a large fee increase for most pupils when they reach sixth-form age, even if they are continuing at the same school and travelling on the same bus.

• Higher fees for both distance banding and flat rate proposals

- We have considered higher charge amounts as the contract costs that we are paying for school buses are rising significantly.
- However, even though our costs are continuing to increase, we are aware that there is a limit on how much extra parents / carers can afford in the current difficult financial climate.
- For this reason, we have applied only a 3% increase to our 2022 to 2023 charges to enable comparison to proposed charges for 2023 to 2024 academic year.

• Closing the Spare Seats scheme

 Buses would run with a limited number of vacant seats. This does not align with our climate change ambitions. Result in a loss of income which helps fund our services.

Updates to our home to school transport policies

We are proposing some minor changes to make the policies clearer and easier to understand. These changes include:

- The types of travel assistance Buckinghamshire Council may offer
- The approach for elective home education (EHE) and education other than at school (EOTAS)
- Criteria for travel assistance for students with special educational needs and disabilities (SEND) aged 16 to 19
- The Personal Transport Budget offer
- Transport during the school / college day. Clarity of what is and what is not provided by Buckinghamshire Council's transport team

The proposed changes are highlighted in yellow in the draft Home to School Transport Policy and draft Post-16 Transport Policy Statement documents.

We are also proposing a 3% increase to the charge for Post-16 students with SEND using Buckinghamshire Council arranged transport. This is below the rate of inflation (9.9% as of September 2022) and despite rising transport costs.

The charge is based on the number of days travelled at the start of the academic year, and is a contribution to the cost of providing transport:

Number of days travelled per week	Annual charge for 2023 to 2024	Reduced annual charge for 2023 to 2024 for evidenced financial hardship
5 days per week	£954	£636
4 days per week	£764	£508
3 days per week	£572	£382
2 days per week	£382	£254
1 day per week	£190	£127

As with current charges, payments can be made monthly or annually by Direct Debit.

We are not proposing any further substantial changes to the Home to School Transport Policy or the Post-16 Transport Policy Statement 2023 to 2024.
